### Membership Categories and Fees

Basic Membership : Entitles you to the daily use of the clubhouse, grounds and launching ramp for your own boat for the season. No voting rights with this membership.

Dry Berth Membership : Includes all of the benefits of a basic membership plus daily / overnight

storage of your boat and trailer on the DYC grounds. One membership is entitled to one vote at the AGM.

Wet Berth Membership : Includes all of the benefits of a basic membership plus a wet berth as assigned by the Harbourmaster. One membership is entitled to one vote at the AGM.

Small Wet Berth Membership : Similar to a wet berth membership but applies to berths 1,2,13,14,15,16,17,52 and 53 which are suitable for smaller vessels. One membership is entitled to one vote at the AGM.

Wet Berth \$712, after April 30th \$938

Dry Berth \$327, after April 30th \$537

Small Wet Berth \$565, after April 30th \$791

Basic \$142, after April 30th \$142

If a member wishes to keep more than one boat at the club, a separate membership fee must be paid for each wet berth or dry berth. The Basic Membership portion of the fee (\$142) will be deducted from the second and subsequent memberships.

Memberships that have not been renewed by April 30, 2023 risk losing their wet berth.
