DYC Sponsor: _____

Basic Membership: Entitles you to the daily use of the clubhouse, grounds and launching ramp for your own boat for the season. No voting rights with this membership.

Dry Berth Membership: Includes all of the above plus daily / overnight storage of your boat and trailer on the DYC grounds. One membership is entitled to one vote at the AGM.

Wet Berth Membership: Includes all of the above plus a wet berth as assigned by the Harbourmaster. One membership is entitled to one vote at the AGM.

Small Wet Berth Membership: Register early! There are a very limited number of berths available along the north wall, only suitable for motor boat up to 16 feet. Will be assigned on a first come – first served basis. One membership is entitled to one vote at the AGM.

2017 MEMBERSHIP FEE SCHEDULE (with 13% HST)

DUES PAID BEFORE APRIL 30:

Wet Berth \$630 + \$82 = \$712

Dry Berth \$289 + \$38 = \$327

Small Wet Berth \$500 + \$65 = \$565

Basic \$126 + \$16 = \$142

DUES PAID AFTER APRIL 30:

\$830 + \$108 = \$938

\$475 + \$62 = \$537

\$700 + \$91 = \$791

\$126 + \$16 = \$142

If a member wishes to keep more than one boat at the club, a separate membership fee must be paid for each wet berth or dry berth. The Basic Membership portion of the fee (\$126.00) will be deducted from second and subsequent memberships.

Memberships that have not been renewed by April 30, 2017 risk losing their wet berth.

Proof of Insurance

It is a mandatory requirement of Dryden Yacht Club that every vessel on Club property must carry liability insurance. Your insurance information must accompany this application. No boat may be launched or stored on club property unless your insurance information has been provided. Upon request, the DYC Commodore may conduct a vessel survey for insurance purposes.
